

LOCAL STATE OF EMERGENCY DECLARATION

TAYLOR COUNTY BOARD OF COUNTY COMMISSIONERS

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF TAYLOR COUNTY, FLORIDA DECLARING A LOCAL STATE OF EMERGENCY; WAIVING PROCEDURES AND FORMALITIES DURING THE PERIOD OF SUCH EMERGENCY; AUTHORIZING AND DIRECTING THE TAYLOR COUNTY EMERGENCY MANAGEMENT DIRECTOR TO TAKE WHATEVER PRUDENT ACTIONS AS MAY BE NECESSARY TO PROTECT THE HEALTH, SAFETY AND WELFARE OF THE COMMUNITY PURSUANT TO THIS DECLARATION.

WHEREAS, since oil continues to spill from the Deepwater Horizon drilling platform and all efforts to stop the discharge have failed and may not succeed for an extended period of time, and the Taylor County coastline could be affected.

WHEREAS, Governor Charley Crist has issued Executive Order Number 10-100 which proclaims a state of emergency exists in 19 Florida counties, including Taylor County.

BE IT THEREFORE RESOLVED that the Taylor County Board of County Commissioners hereby declares that a State of Emergency exists in Taylor County. All county agencies are to provide any assistance necessary under the authority of Florida Statute 252 and the Taylor County Comprehensive Emergency Management Plan.

WHEREAS, Section 252.38(3)(a), Florida Statutes empowers political subdivisions to declare a State of Local Emergency for a period of up to seven (7) days, but may be extended, as necessary, in 7 day increments and

WHEREAS, Section 252.38(3)(a), Florida Statutes empowers political subdivisions to waive the procedures and formalities otherwise required by law pertaining to;


1. Performance of public work and taking whatever action is necessary to ensure the health, safety and welfare of the community.
2. Entering into contracts
3. Incurring obligations
4. Employment of permanent and temporary workers
5. Utilization of voluntary workers
6. Rental of equipment
7. Acquisition and distribution with or without compensation of supplies, materials and facilities.
8. Appropriation and expenditure of public funds; and

WHEREAS, Section 501.106, Florida Statutes prohibits price gouging in a declared State of Emergency.


This Resolution shall become effective immediately upon its adoption.

OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 10-100

(Amending Executive Order 10-99
Emergency Management - Deepwater Horizon)

On April 30, 2010, I issued Executive Order 10-99 declaring a state of emergency due to the threat that oil leaking from Deepwater Horizon drilling platform and well poses to the State of Florida.

I found that this event threatens the State of Florida with a major disaster and proclaimed a state of emergency exists for the counties of Escambia, Santa Rosa, Okaloosa, Walton, Bay and Gulf.

As the oil continues to spill from the well and all efforts to stop the discharge have failed and may not succeed for an extended period of time, more Florida counties could be affected.

As Governor, I am responsible to meet the dangers presented to this state and its people by this emergency. Therefore, by virtue of the authority vested in me by Article IV, Section 1 (a) of the Florida Constitution and by the State Emergency Management Act (Chapter 252, Florida Statutes), and all other applicable laws, I issue the following Executive Order:

Section 1. Executive Order 10-99 is amended to include the following additional counties for the state of emergency: Franklin, Wakulla, Jefferson, Taylor, Dixie, Levy, Citrus, Hernando, Pasco, Pinellas, Hillsborough, Manatee and Sarasota counties.

Section 2. Except as amended herein, Executive Order 10-99 is ratified and reaffirmed.
